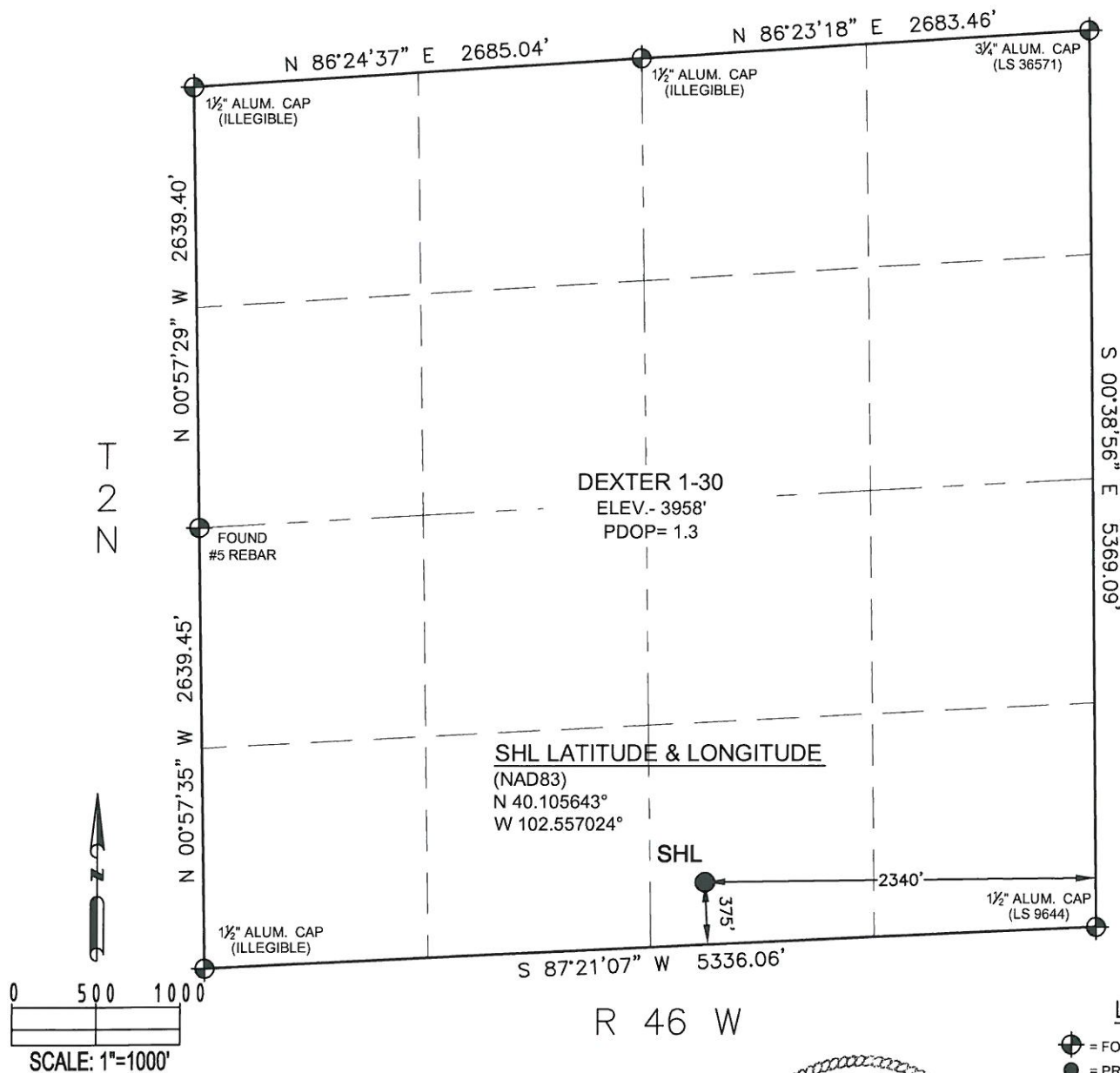


WELL LOCATION CERTIFICATE

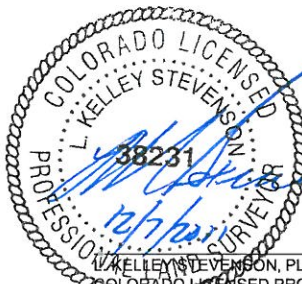
