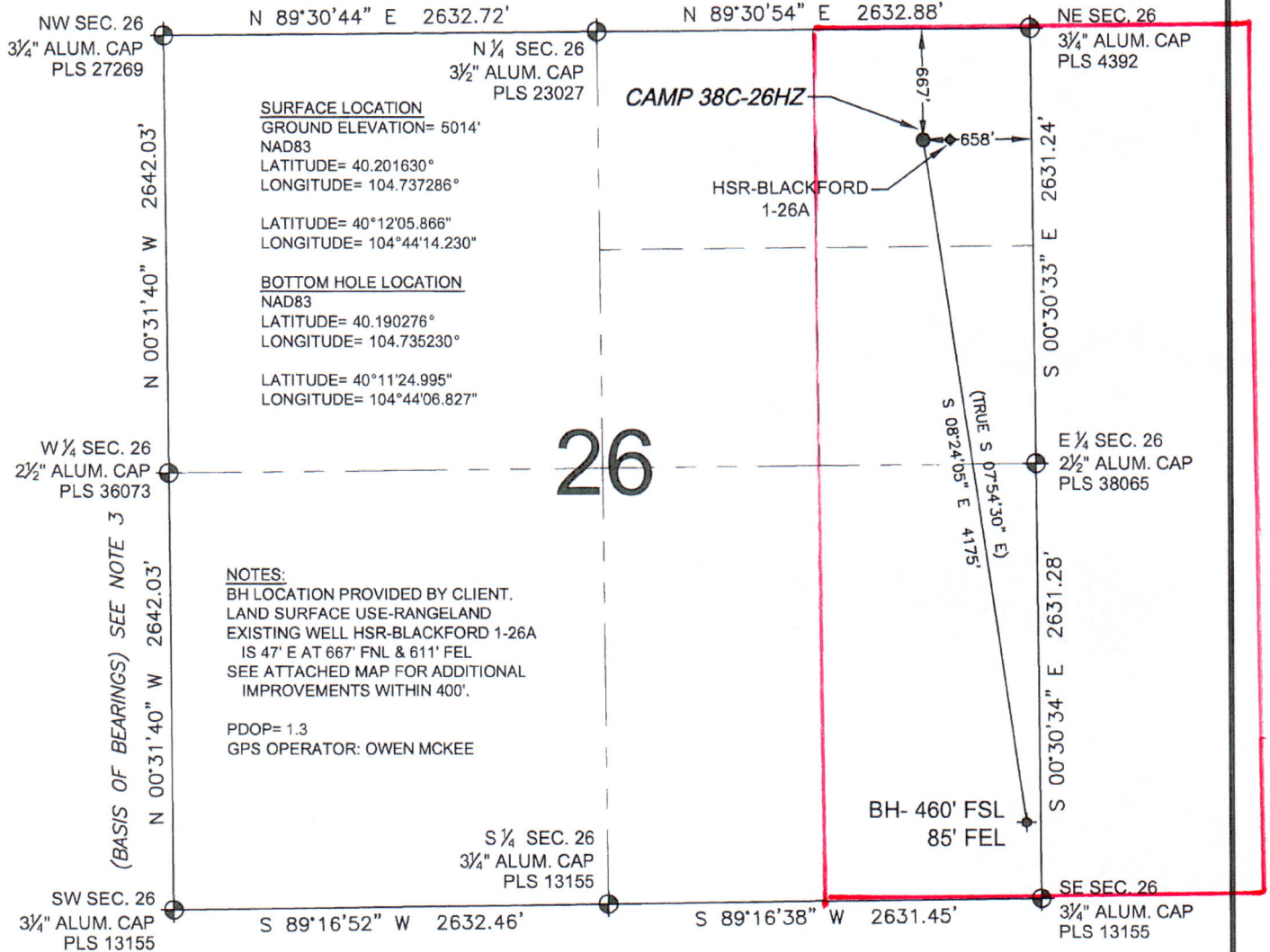

WELL LOCATION CERTIFICATE: CAMP 38C-26HZ

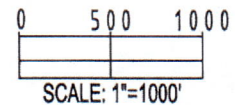
