Black Raven Energy is requesting Expedited Approval of Forms 2 & 2A (Rule 303.1) due to exigent circumstances and therefore has attached a copy of the surface owner waiver as part of this application. RAILROAD IS 3.99 +/- MILES FROM SITE. THERE ARE NO VISIBLE IMPROVEMENTS WITHIN 400 FT OF SITE. NEAREST WATER WELL IS 4649 FT FROM SITE (RECEIPT - 0415786, PERMIT - 203999, USE DOMESTIC). THERE IS A DRY INTERMITTENT CREEK 1861 FEET FROM SITE. THE LOCATION IS IN A SENSITIVE AREA DUE TO BEING WITHIN THE NORTHERN HIGH PLAINS DESIGNATED BASIN. NO COA'S ARE NEEDED FOR THIS LOCATION. IT MAY BE NECESSARY TO PLACE A PUMPING UNIT ON THE FACILITY AT SOME POINT IN THE FUTURE TO AID WITH GAS PRODUCTION. IT WILL REQUIRE EITHER A GAS OR ELECTRIC MOTOR.
