Black Rave Energy is requesting Expedited Approval of Forms 2 & 2A (Rule 303.1) due to exigent circumstances and therefore is attaching a copy of the surface owner waiver asaprt of this application. RAILROAD IS .46 MILES AWAY FROM SITE. THERE ARE NO VISABLE IMPROVEMENTS WITHIN 400 FEET OF SITE EXCEPT AN EXISTING OVERHEAD POWER LINE AND COUNTY ROADS. NEAREST WATER WELL 1283 +/- FEET FROM SITE (RECEIPT:0208381A,PERMIT:25264-F-). THERE IS A DRY EPHERMERAL STREAM LOCATED 6909 FEET WEST OF THE LOCATION. THE LOCATION IS IN SENSITIVE AREA DUE TO BEING WITHIN THE NORTHERN HIGH PLAINS DESIGNATED BASIN. NO COA'S ARE NEEDED FOR THIS LOCATION. A PUMP JACK MAY BE NECESSARY TO PLACE ON FACITILY IN THE FUTURE TO HELP WITH GAS PRODUCTION . IT WILL REQUIRE EITHER ONE GAS OR ONE ELECTRIC MOTOR TO RUN THE PUMPING JACK UNIT WHICH WILL BE DETERMINED AT THE TIME OF INSTALLATION.
