Black Raven Energy is requesting Expedited Approval of Forms 2 & 2A (Rule 303.1) due to exigent circumstances and therefore has attached a copy of the surface owner waiver as part of this application. RAILROAD IS .28 MILES AWAY FROM SITE. THERE ARE NO VISABLE IMPROVEMENTS WITHIN 400 FEET OF SITE. NEAREST WATER WELL 4,488 FEET FROM SITE (RECEIPT:0391423, PERMIT:191134--A, USE:DOMESTIC). THERE IS A SMALL LAKE LOCATED 6441 FEET WEST OF LOCATION. THE LOCATION IS IN A SENSITIVE AREA DUE TO BEING WITHIN THE NORTHERN HIGH PLAINS DESIGNATED BASIN. NO COA'S ARE NEEDED FOR THIS LOCATION. A PUMP JACK MAY BE NECESSARY TO PLACE ON FACILITY IN THE FUTURE TO HELP WITH GAS PRODUCTION. IT WILL REQUIRE EITHER ONE GAS OR ONE ELECTRIC MOTOR TO RUN THE PUMPING JACK UNIT WHICH WILL BE DETERMINED AT THE TIME OF INSTALLATION.
