Pursuant to Colorado Oil & Gas Commission ("COGCC") Rule 305(e)(1)(B), Chesapeake Operating, Inc. ("Chesapeake") is required as mere formality to provide advance notice of its expected commencement date of operations with heavy equipment on your property described above as well as a plat of the proposed locations and contact information.
