Static water level was determined from water well permit #: 133551- - located (SENE) Sect. 32 6N 67W , approximately 2083' from location. This well pumped @ 0.5 gpm with a static water level of 125'. There is no elevation listed for this well, but topographic maps show it as approximately 36' below location. Correcting for this difference results in an estimate of 161' to groundwater at location. Certain Form 2's remain in DRAFT pending legal information for notices. This will be submitted as soon as is practicable. Location is listed as sensitive area due to proximity to surface waters.
