Operator must implement site-specific best management practices in accordance with good engineering practices, including, but not limited to, construction of a berm or diversion dike, site grading, or other comparable measures, sufficient to protect Crow Creek located 293 feet to the east of the oil and gas location from a release of drilling, completion, produced fluids, and chemical products.
