RAILROAD IS 1.52 +/- MILES FROM SITE. THERE ARE NO VISIBLE IMPROVEMENTS WITHIN 400 FT EXCEPT AN EXISTING PIVOT IRRIGATION SYSTEM. NEAREAST WATER WELL IS 1208 +/- FEET FROM SITE (RECEIPT - 0084543, PERMIT - 92750-A, USE - IRRIGATION -STOCK). THERE IS A DRY INTERMITTENT POND 1010 FT FROM SITE. THE LOCATION IS IN A SENSITIVE AREA DUE TO BEING WITHIN THE NORTHERN HIGH PLAINS DESIGNATED BASIN. NO COA'S ARE NEEDED FOR THIS LOCATION. IT MAY BE NECESSARY TO PLACE A PUMPING UNIT ON THE FACILITY TO AID WITH GAS PRODUCTION. THE PUMPING UNIT WILL REQUIRE EITHER ONE GAS OR ONE ELECTRIC MOTOR.
