RAILROAD IS 1.81 +/- MILES FROM SITE. THERE ARE NO VISIBLE IMPROVEMENTS WITHIN 400 FEET OF SITE EXCEPT THE PIVOT IRRIGATION SYSTEM AND THE COUNTY ROAD. NEAREST WATER WELL IS 1055 +/- FEET FROM SITE (RECEIPTS 9053342, PERMIT 3358f, USE IRRIGATION). THERE IS A DRY INTERMITTENT POND 2451 FEET FROM SITE. THE LOCATION IS IN A SENSITIVE AREA DUE TO BEING IN THE NORTHERN HIGH PLAINS DESIGNATED BASIN. NO COA'S ARE NEEDED FOR THIS LOCATION. IT MAY BE NECESSARY TO PLACE A PUMPING UNIT ON THE FACILITY AT SOME POINT IN THE FUTURE. THE PUMPING UNIT WILL REQUIRE EITHER ONE GAS OR ONE ELECTRIC MOTOR.
