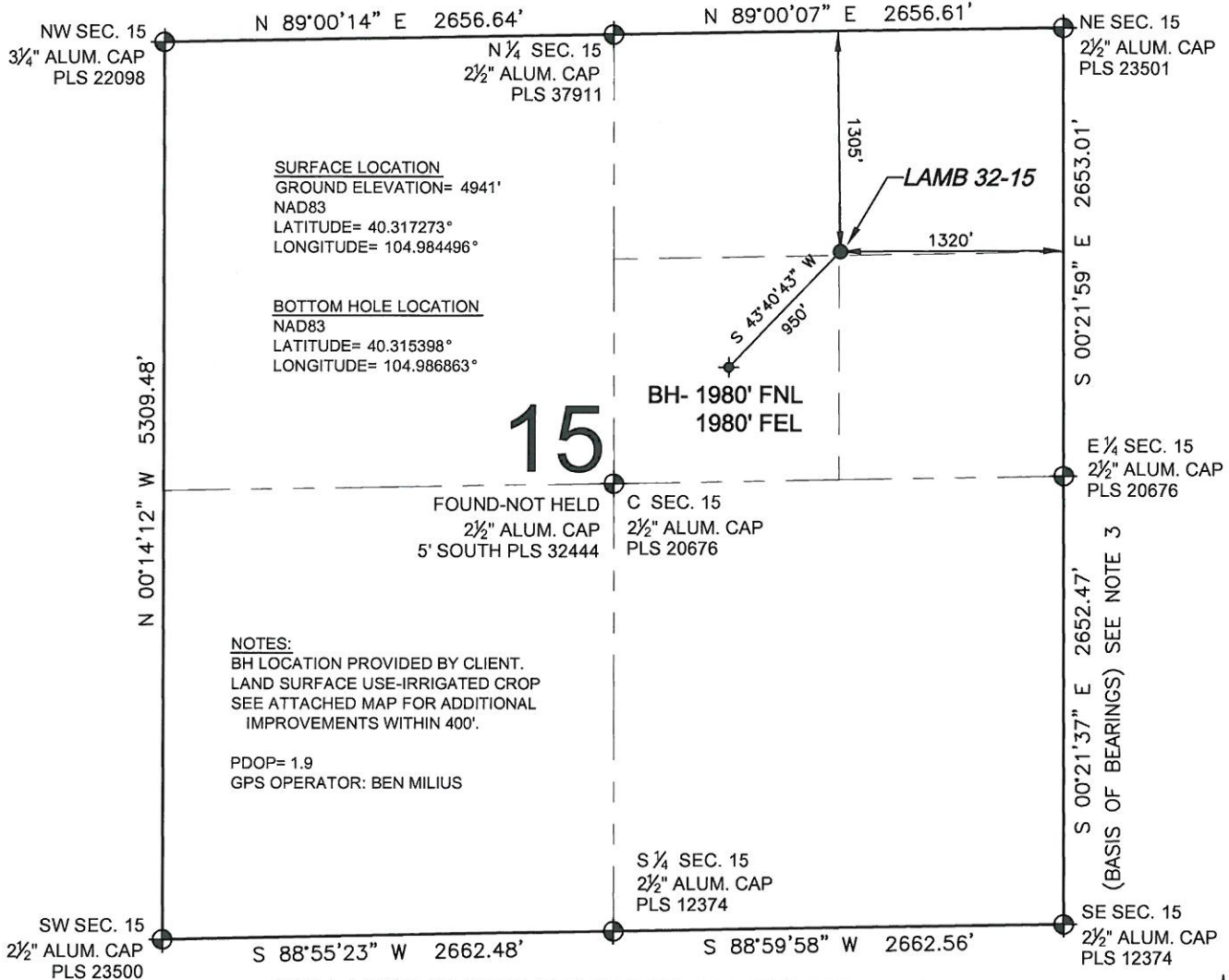


WELL LOCATION CERTIFICATE: LAMB 32-15

SECTION 15, TOWNSHIP 4 NORTH, RANGE 68 WEST, 6TH P.M.



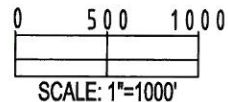
