Black Raven Energy is requesting Expedited Approval of Forms 2 & 2A (Rule 303.1) due to exigent circumstances and therefore has attached a copy of the surface owner waiver. RAILROAD IS 4.08 +/- MILES FROM SITE. THERE ARE NO VISIBLE IMPROVEMENTS WITHIN 400 FEET OF SITE. NEAREST WATER WELL IS 5267 +/- FEET FROM SITE (RECEIPT - 0415786, PERMIT 203999, USE DOMESTIC). THERE IS A DRY INTERMITTENT STREAM 1335 FEET FROM SITE. THE LOCATION IS IN A SENSITIVE AREA DUE TO BEING WITHIN THE NORTHERN HIGH PLAINS DESIGNATED BASIN. NO COA'S ARE NEEDED FOR THIS LOCATION. IT MAY BE NECESSARY TO PLACE A PUMPING UNIT ON THE FACILITY AT SOME POINT IN THE FUTURE TO AID WITH GAS PRODUCTION. IT WILL REQUIRE EITHER ONE GAS OR ONE ELECTRIC MOTOR TO RUN THE PUMPING UNIT.
