RAILROAD IS 2109 +/- FEET FROM LOCATION. THERE ARE NO VISIBLE IMPROVEMENTS WITHIN 400 FEET EXCEPT A COUNTY ROAD AND OVERHEAD UTILITY 248 ft. FROM SITE. NEAREST WATER WELL IS 1470 +/- FEET FROM SITE (RECEIPT 3628018, PERMIT-277194, USE- DOMESTIC/STOCK). THERE IS A INTERMITTENT POND 2055 FEET FROM SITE. THE LOCATION IS IN A SENSITIVE AREA DUE TO BEING WITHIN THE NORTHERN HIGH PLAINS DESIGNATED BASIN. NO COA'S ARE NEEDED FOR THIS LOCATION. IT MAY BE NECESSARY TO PLACE A A PUMPING UNIT ON THE FACILITY AT SOME POINT IN THE FUTURE TO AID WITH GAS PRODUCTION. THE PUMPING UNIT WILL REQUIRE EITHER ONE GAS OR ONE ELECTRIC MOTOR.
