Railroad is approx. 1.29 miles from site. Other than pivot tracks, there are no visible improvements within 400' of site except for the pivot head, which is 30.9 feet west of site. The nearest water well is approx. 30.9' from site (RECEIPT: 9053368; PERMIT: 5453-F-; USE: Irrigation). There is a water pit located approx. 1,380' north of site. The location is in a sensitive area due to being within the Northern High Plains Designated Basin. No COA's are needed for this location. A Pump Jack may be necessary to place on facility in the future to help with gas production. It will require either one gas or one electric motor to run the pumping jack unit which will be determined at the time of installation.
