RAILROAD IS 2850 +/- FEET FROM SITE. THERE ARE NO VISIBLE IMPROVEMENTS WITHIN 400 FEET OF SITE. NEAREST WATER WELL IS 2717 +/- FEET FROM SITE (RECEIPT - 0056855C, PERMIT - 19188F, USE IRRIGATION). THERE IS A DRY INTERMITTENT STREAM 575 FEET FROM SITE. THE LOCATION IS IN A SENSITIVE AREA DUE TO BEING WITHIN THE NORTHERN HIGH PLAINS DESIGNATED BASIN. NO COA'S ARE NEEDED FOR THIS LOCATION. IT MAY BE NECESSARY TO PLACE A PUMPING UNIT ON THE FACILITY AT SOME POINT IN THE FUTURE TO AID WITH GAS PRODUCTION. THE PUMPING UNIT WILL REQUIRE EITHER ONE GAS OR ONE ELECTRIC MOTOR.
