NEAREST WATER WELL IS 1424 +/- FEET FROM SITE (RECEIPT - 0111541B, PERMIT - 281555-F, USE - IRRIGATION). THERE IS A DRY INTERMITTENT STREAM 648 FEET FROM SITE. THE LOCATION IS IN A SENSITIVE DUE TO BEING WITHIN THE NORTHERN HIGH PLAINS DESIGNATED BASIN. NO COA'S ARE NEEDED FOR THIS SITE. IT MAY BE NECESSARY TO PLACE A PUMPING UNIT ON THE FACILITY AT SOME POINT IN THE FUTURE TO AID WITH GAS PRODUCTION. THE PUMPING UNIT WILL REQUIRE EITHER ONE GAS OR ONE ELECTRIC MOTOR
