RAILROAD IS 2.37 +/- MILES FROM SITE. THERE ARE NO VISIBLE IMPROVEMENTS WITHIN 400 FEET OF SITE. NEAREST WATER WELL IS 5102 +/- FEET FROM SITE (RECEIPT - 905192, PERMIT - 146748, USE DOMESTIC/STOCK). THERE IS A DRY INTERMITTENT STREAM 2391 FEET FROM SITE. THE LOCATION IS IN A SENSITIVE AREA DUE TO BEING WITHIN THE NORTHERN HIGH PLAINS DESIGNATED BASIN. NO COA'S ARE NEEDED FOR THIS LOCATION. IT MAY BE NECESSARTY TO PLACE A PUMPING UNIT ON THE FACILITY AT SOME POINT IN THE FUTURE TO AID WITH GAS PRODUCTION. THE PUMPING UNIT WILL REQUIRE EITHER ONE GAS OR ONE ELECTRIC MOTOR.
