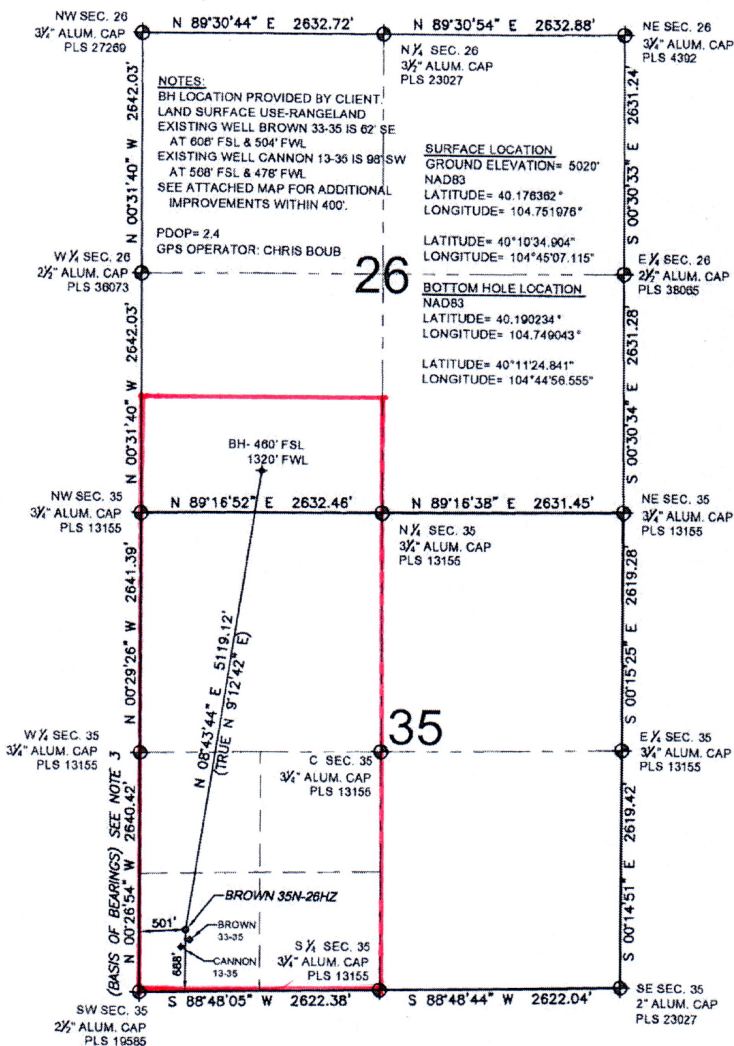

WELL LOCATION CERTIFICATE: BROWN 35N-26HZ

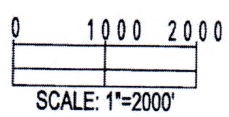

- BH = BOTTOM HOLE

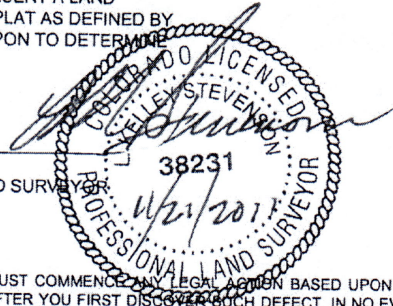
