At this time, DOE does not request any additional information but would encourage COGCC to place general language in the permit such that the company would accommodate DOE sampling requests in the future. DOE agrees with the COGCC assessment that the pad is located within the three-mile notification radius in the SENE, Section 21-T7S-R95W. Accordingly, DOE agrees with COGCC that all wells fall under the Tier 2 sampling and monitoring of the COGCC Rulison Sample and Analysis Plan and wells are located in Sectors 10 and 11 of the Rulison SAP. The Bottom-Hole-Locations (BHL's) range from 2.24 to 2.99 miles from the the Rulison site. DOE will continue to review the proposed locations and subsurface orientations of the propose drilling for documentation when sampling occurs. Encana has submitted eight FORM 2's APD for wells within the Project Rulison 3 mile radius. All locations are in Tier 2 of the Rulison SAP.

The surface location is located within the 3 mile radius as well in SENE, Section 21-T7S-R95W.

The BHL's range from 2.24-2.99 miles from the project well and are located in the NE/4 of Section 21 and the SW/4 of Section 22, T7S-R95W.

The attached map plots the locations of the wells listed in the attached table. The proposed wellbores are plotted with red lines.

Jevin Croteau with Encana has already submitted notification of these proposed locations to you.
