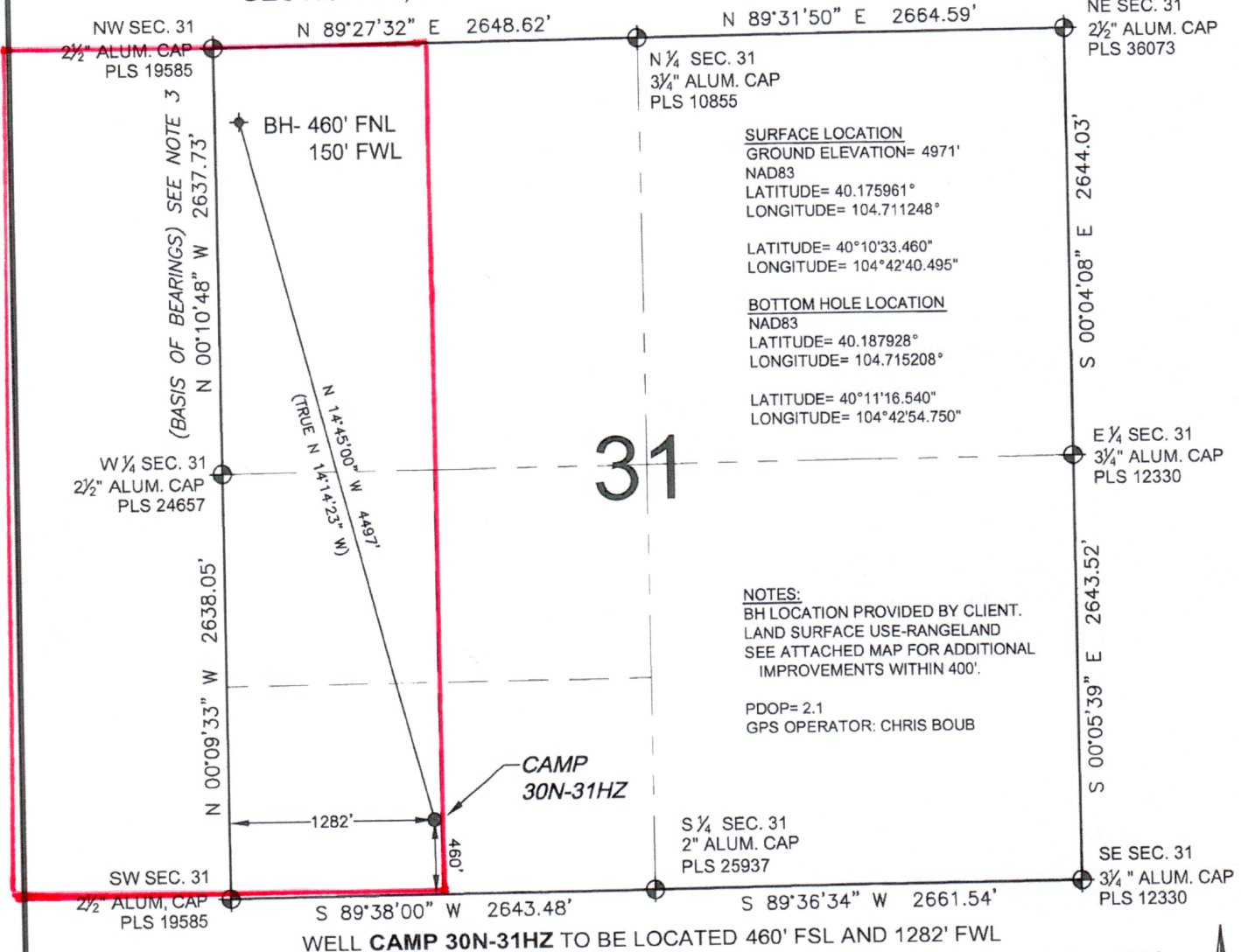

WELL LOCATION CERTIFICATE: CAMP 30N-31HZ

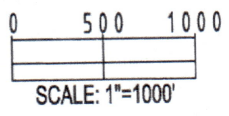
