Flare stack will be removed after a gas line is installed. One of the two heater treaters will be removed when production volumes fall below the capacity of a single heater treater. Depth to ground water determined from Water Well Permit No. 44139, which is the closest water well per COGCC GIS. This water well lies to the northwest in Section 22 T10N R63W. The closest water well per the location drawing is Water Well permit #36626 which is located to the of southeast of the location in in Section 26 T10N R63W.
