RAILROAD IS 1.83 +/- MILES FROM SITE. THERE ARE NO VISIBLE IMPROVEMENTS WITHIN 400 FEET OF SITE. NEAREST WATER WELL IS 1897 +/- FEET FROM SITE (RECEIPT-0056487A, PERMIT-4979AD, USE IRRIGATION). THERE IS A DRY INTERMITTENT STREAM 519 FEET FROM LOCATION. THE LOCATION IS IN A SENSITIVE AREA DUE TO BEING WITHIN THE NORTHERN HIGH PLAINS DESIGNATED BASIN. NO COA'S ARE NEEDED FOER THIS LOCATION. IT MAY BE NECESSARY TO PLACE A PUMPING UNIT ON THE FACILITY AT SOME POINT IN THE FUTURE TO AID WITH GAS PRODUCTION. THE PUMPING UNIT WILL REQUIRE EITHER ONE GAS OR ONE ELCTRIC MOTOR.
