RAILROAD IS 1100 +/- FEET FROM SITE. THERE ARE NO VISIBLE IMPROVEMENTS WITHIN 400 FEET OF LOCATION. NEAREST WATER WELL IS 1837 +/- FEET FROM SITE (RECEIPT-0208381A, PERMIT-25164-F, USE IRRIGATION). THERE IS A DRY INTERMITTENT STREAM 4545 FEET FROM SITE. THE LOCATION IS IN A SENSITIVE AREA DUE TO BEING WITHIN THE NORTHERN HIGH PLAINS DESIGNATED BASIN. NO COA'S ARE NEEDED FOR THIS LOCATION. IT MAY BE NECESSARY TO PLACE A PUMPING UNIT ON THE FACILITY AT SOME POINT IN THE FUTURE TO AID WITH GAS PRODUCTION. THE PUMPING UNIT WILL REQUIRE EITHER ONE GAS OR ONE ELECTRIC MOTOR.
