RAILROAD IS 1.7 +/- MILES FROM SITE. THERE ARE IMPROVEMENTS WITHIN 400 FEET (OVERHEAD POWER LINE & ROAD - LOCATION DRAWING ATTACHED). NEAREST WATER WELL IS 2258 +/- FEET FROM LOCATION (RECEIPT-9053495, PERMIT-12357F, USE IRRIGATION). THERE IS A DRY INTERMITTENT STREAM 268 FEET FROM SITE. THE LOCATION IS IN A SENSITIVE AREA DUE TO BEING WITHIN THE NORTHERN HIGH PLAINS DESIGNATED BASIN. NO COA'S ARE NEEDED FOR THIS LOCATION. IT MAY BE NECESSARY TO PLACE A PUMPING UNIT ON THE FACILITY AT SOME POINT IN THE FUTURE TO AID WITH GAS PRODUCTION. THE PUMPING UNIT WILL REQUIRE EITHER ONE GAS OR ONE ELECTRIC MOTOR.
