

REINSTATEMENT AND 2nd AMENDMENT OF SURFACE USE AGREEMENT

STATE: COLORADO

COUNTY: GARFIELD

KNOW ALL MEN BY THESE PRESENTS:

WHEREAS, under the date of October 25, 2005, ExxonMobil Oil Corporation ("Surface Owner") and Williams Production RMT Company ("Operator"), with Surface Owner and Operator collectively called the "Parties", did execute a Surface Use Agreement (the "Agreement"); and,

WHEREAS, under the date of May 19, 2006, Surface Owner and Operator did execute an Amendment of Surface Use Agreement (the "Amendment"); and,

WHEREAS, Williams Production RMT Company became Williams Production RMT Company LLC as set forth in the document recorded at Reception #793098 of the official records of Garfield County, State of Colorado; and,

WHEREAS, Williams Production RMT Company LLC is now known as WPX Energy Rocky Mountain, LLC as set forth in a document to be recorded in the official records of Garfield County, State of Colorado within one (1) year of the date of this instrument; and,

WHEREAS, the Agreement provided for the use of the surface estate to drill, equip, and operate certain wells to be located in Section 20 of Township 6 South, Range 95 West, 6th P.M., and further described in the Agreement; and,

WHEREAS, it is the desire of the Operator to use the existing surface location, Well Pad AP 21-20-695, for the drilling, completion, and operation of wells as described on the attached amended Exhibit "A"; and,

WHEREAS, it is the desire of the Parties to amend the Exhibit "B" of the Amendment to include Section 17 of Township 6 South, Range 95 West, 6th P.M.; and,

WHEREAS, the Agreement, as amended, had an expiration date of December 1, 2006, it is the desire of the Parties to execute this Reinstatement and 2nd Amendment of Surface Use Agreement (the "2nd Amendment") reinstating, ratifying and reaffirming the Agreement and extending the expiration date of the Agreement until December 31, 2013.

NOW, THEREFORE, in consideration of the premises stated herein and other good and valuable consideration, the receipt and adequacy of which are hereby acknowledged by the Parties hereto, it is agreed:

1. The Parties reinstate, ratify, reaffirm and agree to be bound by all the terms and conditions of the Agreement, as herein amended.
2. The Agreement and the Amendment shall be amended such that the "Lands" also include land located in Sections 17 and 20 of Township 6 South, Range 95 West, 6th P.M. as follows:
Township 6 South, Range 95 West, 6th P.M.
Section 17: SE/4SW/4
Section 20: Portions of the NW/4 and NW/4NW/4NE/4 lying in and being a part of La Paz Placer Mining Claims Nos. 10, 11, and 12
3. Surface Owner agrees that Operator may use the one (1) existing surface location, Well Pad AP 21-20-695, for the drilling, completion and operation of wells as described on the attached Exhibit "A" (the "Wells").
4. Paragraph 1 of the Agreement shall be deleted and replaced with the following:

Operator may begin operations to drill the Wells from existing Well Pad AP 21-20-695 any time prior to December 31st, 2013, or any time thereafter as mutually agreed to by Surface Owner and Operator.

5. Except as provided herein, all other terms and conditions of the Agreement and subsequent amendments remain unaltered and are in full force and effect as of the date hereof.

6. This 2nd Amendment shall be binding on any and all successors and assigns of the Parties.

7. The recitals and all exhibits attached hereto are incorporated herein for all purposes.

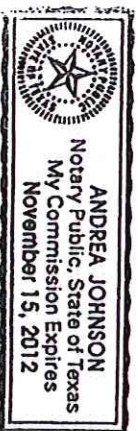

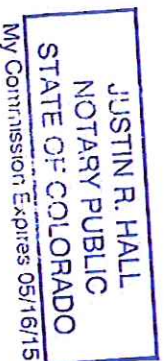
