Siebring 5-63-32-32H being 2005 feet FNL and 232 feet FEL of Section 32, Township 5 North, Range 63 West, 6th P.M., Weld County, Colorado, which surface location is approximately 228 feet outside of the 400' Window of Subject Lands.

Siebring 5-63-32-48H being 2028 feet FNL and 232 feet FEL of Section 32, Township 5 North, Range 63 West, 6th P.M., Weld County, Colorado, which surface location is approximately 228 feet outside of the 400' Window of Subject Lands.
