RAILROAD IS 1.46 +/- MILES FROM SITE. THERE ARE NO VISIBLE IMPROVEMENTS WITHIN 400 FT OF SITE. NEAREST WATER WELL IS 2546 +/- FEET FROM SITE (RECEIPT; 9053495 P, PERMIT; 12357 F, USE IRRIGATION). THERE IS A DRY INTERMITTENT STREAM 2268 FT FROM SITE. THE LOCATION IS IN A SENSITIVE AREA DUE TO BEING WITHIN THE NORTHERN HIGH PLAINS DESIGNATED BASIN. NO COA'S ARE NEEDED FOR THIS LOCATION. IT MAY BE NECESSARY TO PLACE A PUMPING UNIT ON THE FACILITY AT SOME POINT IN THE FUTURE. THE PUMPING UNIT WILL REQUIRE EITHER ONE GAS OR ONE ELECTRIC MOTOR.
