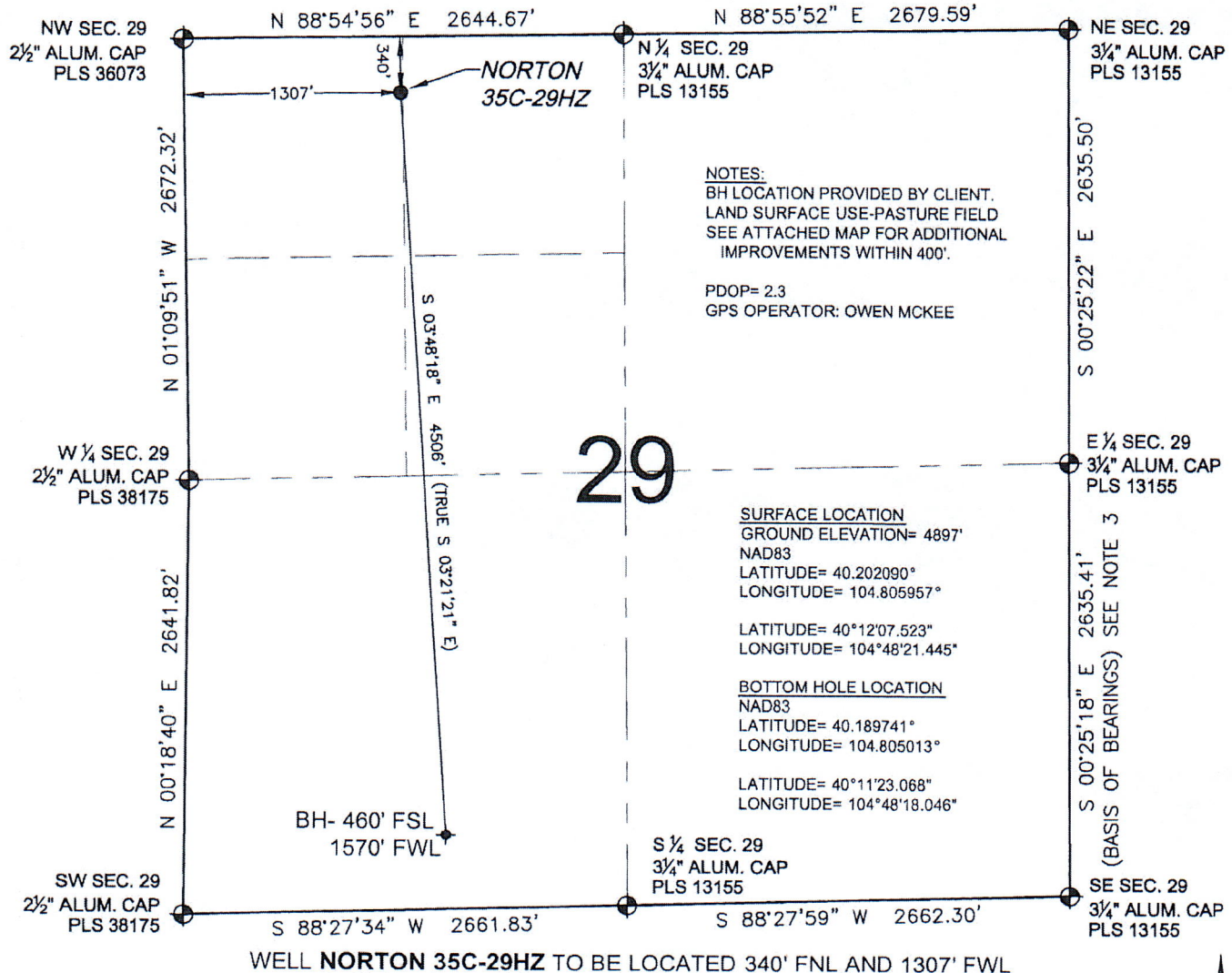

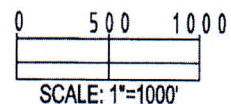
WELL LOCATION CERTIFICATE: NORTON 35C-29HZ

● = PROPOSED WELL ◆ = EXISTING WELL

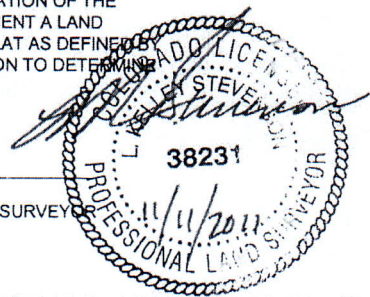
