The surface Casing Setting Depth and Cement Bottom was changed to 1,500 feet as approved by the BLM. All conditions are the same as prior approved permit. This well is part of the RULISON 17L Pad, which is a multi-well pad for 15 wells total. The pad has been built. This re-file will not require any expansion/additional surface disturbance of the pad. The pad is located in Project Rulison 3-Mile Radius Tier II. DOE letter sent 6/4/09. COGCC DOE notice 6/5/09. A closed loop pitless system will be used for this APD. This location does not require a variance from any of the rules listed in COGCC Rule 306.d (1). (A). (ii). This pad is not in a wildlife restricted surface occupancy area. H2S contingency plan attached per Noble Energy, Inc.'s Corporate EHSR policy.
