When site disturbance is greater than one acre, a stormwater discharge permit will be completed per state regulations. 2. Stormwater best management practices will be installed. 3. All materials, waste, and fluids kept on site will be stored in an appropriate manner to prevent contamination with the environment. 2. If a spill occurs, it will be cleaned up using absorbent material and by removing the contaminated soil. 3. Any contaminated soil will be placed in a sealed container that can be disposed of appropriately. 4. All efforts will be made to prevent the spill from migrating off-site or coming into contact with stormwater runoff. 5. The Spill Control and Countermeasures plan, if applicable, will address and control all spill procedures.
Storm Water/Erosion Control	<p>Fugitive Dust and Vehicle Tracking</p> <ol style="list-style-type: none"> 1. Traffic speeds will be limited to control fugitive dust. 2. Watering will be completed to control fugitive dust as needed. 3. Graveled entries will be provided for vehicle tracking control. 4. Furrowing of disturbed soil will be provided at right angles to prevailing winds as needed. 5. Silt fences will be installed for wind breaks as needed.
