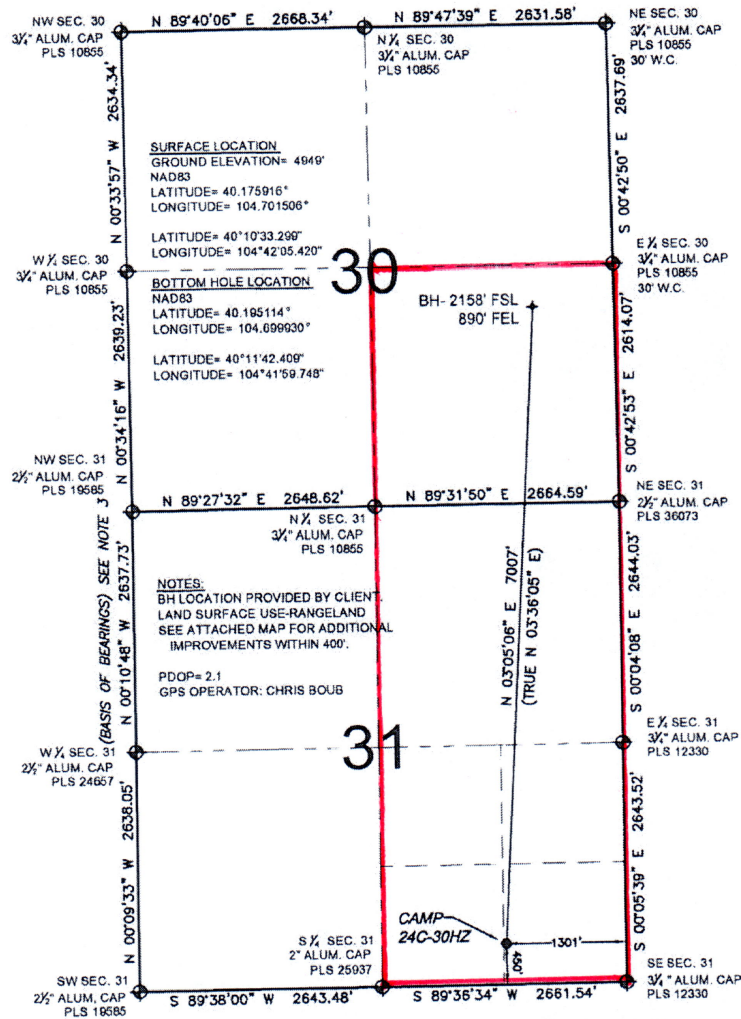

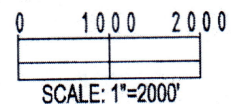
WELL LOCATION CERTIFICATE: CAMP 24C-30HZ

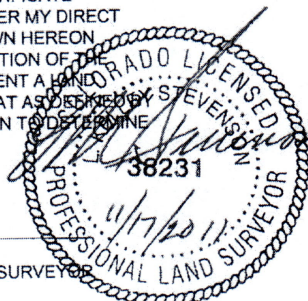

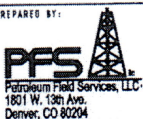
