DOW	<p>The CPW is pleased to comment on Barretts planned well site, 13A-19-691, located ~1500m SE of the edge of Silt, and about 4287m south of I-70. It contains no RSOs, but does include two Sensitive Wildlife Habitats: a Mule Deer Critical Winter Range and an Elk Winter Concentration area. The closest road is Divide Creek Road, which is 423m from the site center, and the closest stream is 341 m away. Construction and drilling activities are scheduled to start May 1st 2013, and reclamation begin on March 1st 2014.</p> <p>Barrett Corporation has included several Best Management Practices (BMPs) addressing their construction techniques, water/erosion control, and wildlife and environmental protection practices. The CPW is very pleased with Barretts BMPs, and encourage the adoption of the following suggestions to further reduce impact to the Mule Deer and Elk during the winter season, and minimize potential animal/bird mortality during the project:</p> <p>a) Minimize well site visitations between December 1 and April 15 during the primary Mule Deer/Elk Winter Range season</p> <p>b) Conduct post-development well site visitation between the hours 10:00am and 3:00pm to minimize stress to wildlife during prime feeding and bedding hours between Dec 1 and April 15.</p> <p>c) Install the protective bird netting over the pit as soon as possible after work completion to help minimize bird mortality per COGCC Rule 902.d.</p>	2/9/2012 11:53:13 AM
