Railroad is 2696 +/- feet from site. There are no visible improvements within 400 feet of site. Nearest water well is 1577 +/- feet from site (Receipt; 00083813, Permit; 8805-AD, Use irrigation). There is a dry intermittent stream 1.12 miles from site. The location is in a sensitive area due to being within the Northern High Plains Designated Basin. No COA's are needed for the location. It may be necessary to place a pumping unit on the facility at some point in the future. The pumping unit will require either one gas or one electric motor.
