Railroad is 4639 +/- feet from location. There are no visible improvements within 400 feet of site. Nearest water well is 594 +/- feet from site (Receipt; 000838113, Permit; 8805-AD, Use irrigation). There is a dry intermittent stream 5245 feet from site. The location is in a sensitive area due to being within the Northern High Plains Designated Basin. No COA's are needed for this location. It may be necessary to place apumping unit on the facility at some point in the future. The pumping unit will require either one gas or one electric motor.
