## Inspector Comment:

On site at 8:30 am. Hole in CSG. At 8:50 am 2 gallons of liquid drispack and sawdust and water is pumped down hole. There are 104 joints of TBG in hole. At 11:00 am cement arrives. At 11:05 am start pumping cement from 3200' to 3100' (Cement Wt. = 15.1 lbs/gal). At 11:35 am cement truck empties 100 Sxs of cement. At 11:40 am rig crew starts tripping 3200 ft. of TBG (104 joints) out of hole. At 12:24 pm Felix Chaves water truck arrives with 80 bbls of water. At 1:14 pm rig crew is done pulling tubing out of hole. At 1:40 pm The Perforators are on site. The tool won't go past 2355 ft. A collar is located and cut at 2299.3 ft., on the 5 1/2" CSG, at 4:10 pm. Wireline gets stuck at 1900', but frees it self by 5:30 pm. 52 joints of 5 1/2" CSG is pulled from hole. Off site at 5:30 pm. Tool Pusher - Gary Valdez, Wireline - The Perforators, Rig - Eastern CO Well Service, Water and Pump - Weber Water, Cement - Huerfano County Concrete.
