At 10:08 am cement truck empties 85 Sxs of cement. At 1:00pm tag plug at 86 ft. Off site at 1:30 pm. Tool Pusher - Gary Valdez, Rig - Eastern CO Well Service, Water and Pump - Weber Water, Cement - Huerfano County Concrete
