Railroad is 1.98 +/- miles from site. There are no visible improvements within 400 feet of site. The nearest water well is 2982 +/- feet from site (Receipt; 9053926, Permit 43015, Use - Domestic). There is a dry intermittent stream 754 feet from site. The location is in a sensitive area due to being within the Northern High Plains Designated Basin. No COA's are needed for this location. It may be necessary to place a pumping unit on the facility at some point in the future. The pumping unit will require either one gas or one electric motor.
