

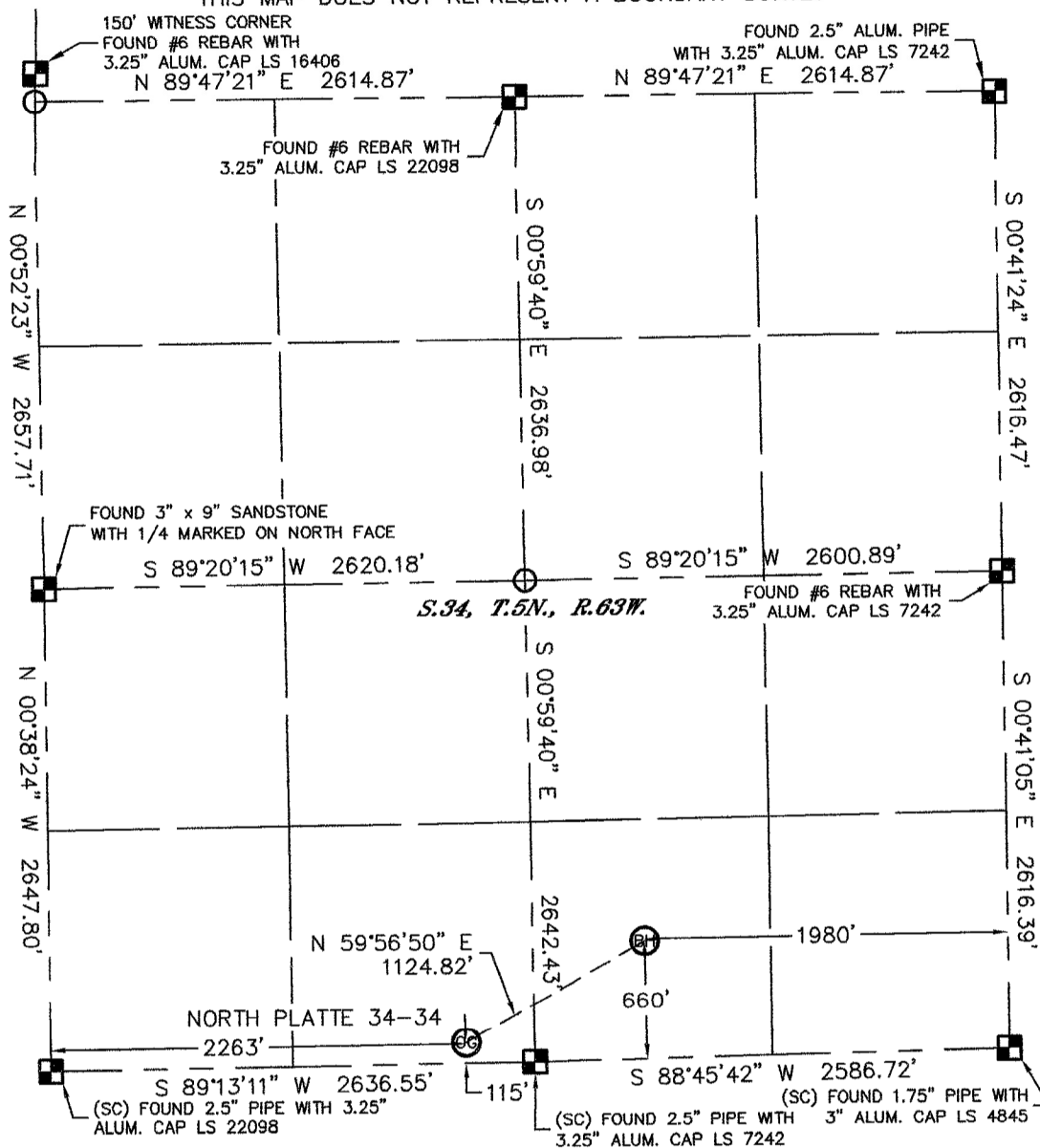

In accordance with a request from KEITH CAPLAN with BONANZA CREEK ENERGY, INC. Lat40°, Inc. has determined the surface location of the NORTH PLATTE 34-34 to be 115' from the SOUTH line and 2263' from the WEST line and the bottom hole to be 660' from the SOUTH line and 1980' from the EAST line as measured at right angles from the section lines of Section 34, Township 5 North, Range 63 West of the Sixth Principal Meridian, County of Weld, State of Colorado.

I hereby state that this Well Location Certificate was prepared by me, or under my direct supervision, that the fieldwork was completed on 4-9-11, for and on behalf of BONANZA CREEK ENERGY, INC. That this is not a Land Survey Plat or an Improvement Survey Plat, and that it is not to be relied upon for establishment of fence, building, or other future improvement lines.

- 1) Bearings shown are Grid Bearings of the Colorado State Plane Coordinate System, North Zone, North American Datum 1983/2007. The lined dimensions as contained herein are based upon the "U.S. Survey Foot."

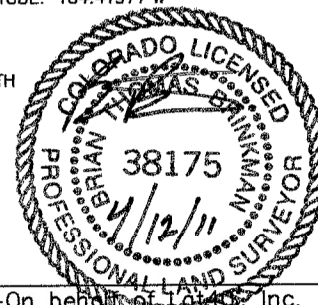
= ALIQUOT MONUMENT AS DESCRIBED
