Dear Mr. Gaddis:

In accordance with the requirement of Rule 305.e.(1).B. of the Colorado Oil and Gas Conservation Commission (COGCC), this letter serves as a 30-day notice by Petroleum Development Corporation d/b/a PDC Energy (PDC), as operator of record, of its intention to conduct drilling operations on the captioned wells.

Reference is made to the meeting we had on site on November 10, 2011, as well as additional discussions since then, when we discussed the location of the well sites, access roads, production facilities and other related matters. For the purposes of having our Initial Consultation, the November 10, 2011 shall be considered as that meeting. The well locations have been be staked and I have attached a copy of the multi page survey. Pursuant to Rule 306, would you please complete the enclosed postage prepaid postcard to request a consultation or to designate a representative for surface consultation for our records, even though the consultation has been done? Also enclosed is a site diagram that depicts the area, per COGCC rules, within which the well(s) may be located, and the proposed location of the well(s), access road(s), and production facilities. Additionally, enclosed please find a copy of the COGCC's brochure describing surface owner rights and responsibilities, and a copy of the COGCC's on-site inspection policy.

I have also enclosed a Waiver Letter (related to the well locations) that is required to be signed and attached to PDC's drilling permit application with the COGCC. It is requested that you sign and return this Waiver. As surface owner you have the responsibility for notifying any affected tenant farmer, lessee or other party that may own or have an interest in any crops or surface improvements that could be affected by these proposed operations. 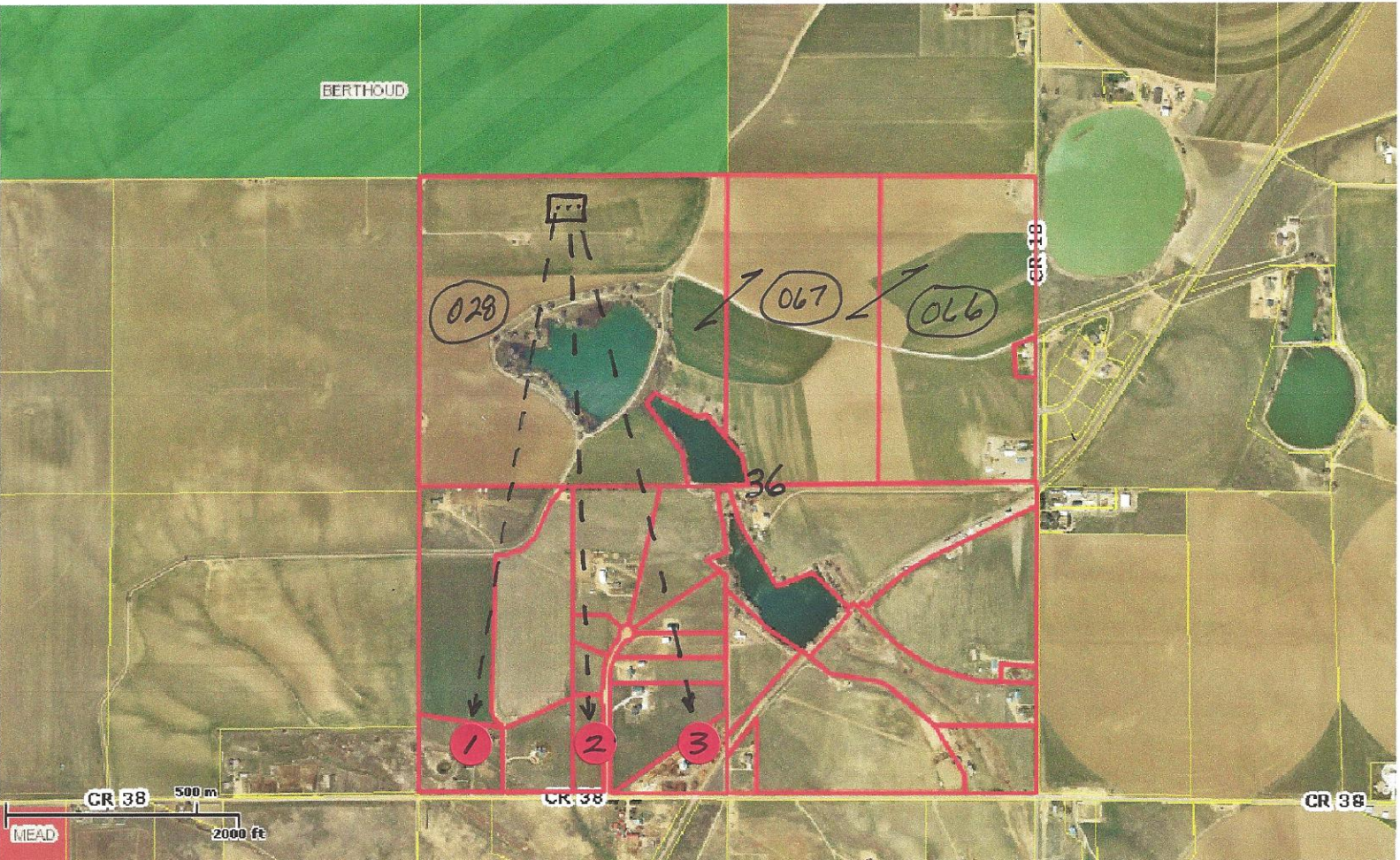
