33. Comments I certify that all conditions in the original permit are the same except the updated SHL, BHL, and casing and cement program. There have been no other changes to land use, well construction or the lease. This Refile Form 2 does not require a Form 2A because the pad has been constructed, a closed loop system is being used so no pits need to be constructed, the refiled well will not require any expansion / additional surface disturbance of the pad beyond what was approved on the Form 2A.
