- All structural berms, dikes, and containment will be inspected periodically to ensure they are operating correctly

#### VEHICLE & LOCATION PROCEDURES

- Vehicles entering location are to be free of chemical, oil, mud, weeds, trash, and debris
- Location to be treated to kill weeds and bladed when necessary

#### WASTE MANAGEMENT PLAN

- To the extent practicable, BBC will reuse, recycle, and/or put to beneficial use all waste materials generated during the drilling, completion and production of wells.
- All BBC waste for disposal shall be transported to facilities authorized by the COGCC or waste disposal facilities approved to receive E&P waste by the Colorado Department of Public Health and Environment.
- These facilities include: BBC permitted; SWD wells, water management facilities, or landfarms, commercial; waste disposal facilities, SWD facilities, water management facilities, or landfarms.
- 'Beneficial use' may include building secondary containment berms or structures, pad construction, road construction or enhancement, or dust suppression. All of these uses shall require that the waste materials meet the applicable federal, state, or local concentration thresholds for the appropriate inorganic and organic compounds or chemicals prior to use.
