The COGCC is reviewing the Form 2A (#2287989) for the Mid-Con Energy Operating HRMU 10-13 location, located in the NWNW Sec 13 T13S R43W Cheyenne county, Colorado. The COGCC requests approval of the following changes and recognition of the conditions of approval prior to passing the Oil and Gas Location Assessment (OGLA).

Based on a review of aerial photographs and topographic maps available on the COGCC website the following amendments need to be made to the form 2A:

#### Land Use

The location appears to be rangeland not CRP land. The current land use should be amended to rangeland.

#### Sensitive Area

The location fall within the Northern High Plains Designated Basin and by rule is considered a sensitive area. The Sensitive Area should be amended to yes.

#### Distance to Surface Water

There is a stream 1, 495 feet south east of the proposed location. The form 2A should be amended from 2,640 feet to 1,495 feet.

#### Distance to Nearest Well

There is a water well (Permit # 83140) located 1,515 feet south of the proposed location. The form

2A should be amended to 1,515 feet from the reported 5,280 feet.

Water well permit # 83140 has a reported depth to ground water of 204 feet. The form 2A should be amended to from 20 feet to 204 feet.
