RAILROAD IS 1.34 +/- MILES FROM SITE. THERE ARE NO VISIBLE IMPROVEMENTS WITHIN 400 FEET OF SITE EXCEPT AN OVER HEAD POWER LINE AND COUNTY ROAD. NEAREST WATER WELL 1954 FEET FROM SITE (RECEPIT:9053352,PERMIT:4760-F-,USE:DOMESTIC). THERE IS A DRY INTERMITTENT POND 1964 FEET FROM LOCATION. THE LOCATION IS IN A SENSITIVE AREA DUE TO BEING WITHIN THE NORTHERN HIGH PLAINS DESIGNATED BASIN. NO COA'S ARE NEEDED FOR THIS LOCATION. A PUMP JACK MAY BE NECESSARY TO PLACE ON FACILITY IN THE FUTURE TO HELP WITH GAS PRODUCTION. IT WILL REQUIRE EITHER ONE GAS OR ONE ELECTRIC MOTOR TO RUN THE PUMPING JACK UNIT WHICH WILL BE DETERMINED AT THE TIME OF INSTALLATION.
