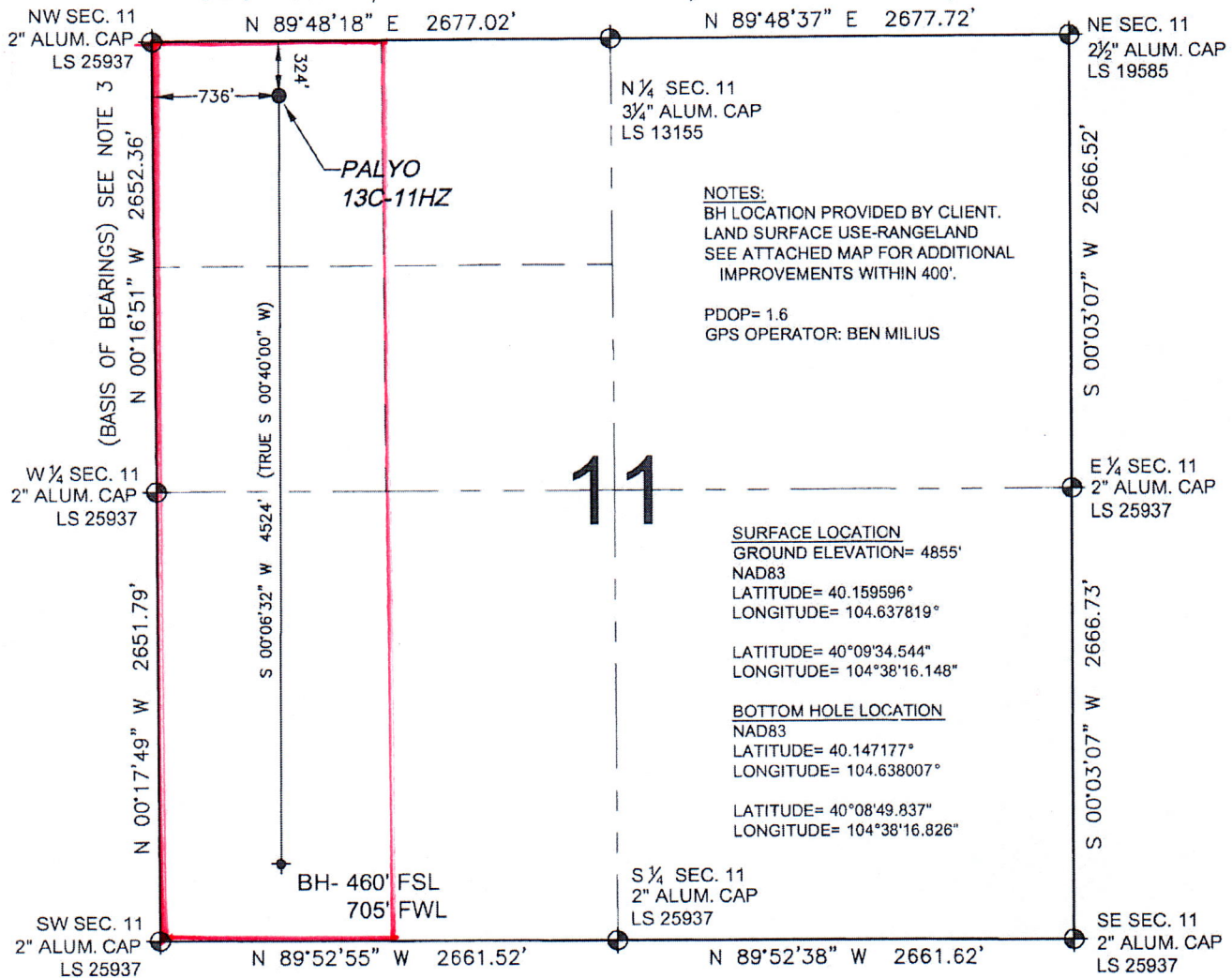

WELL LOCATION CERTIFICATE: PALYO 13C-11HZ

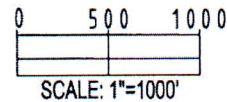

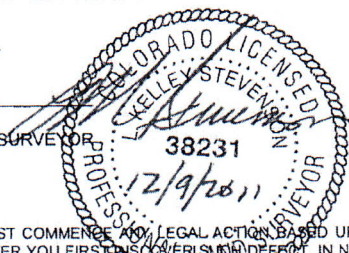
