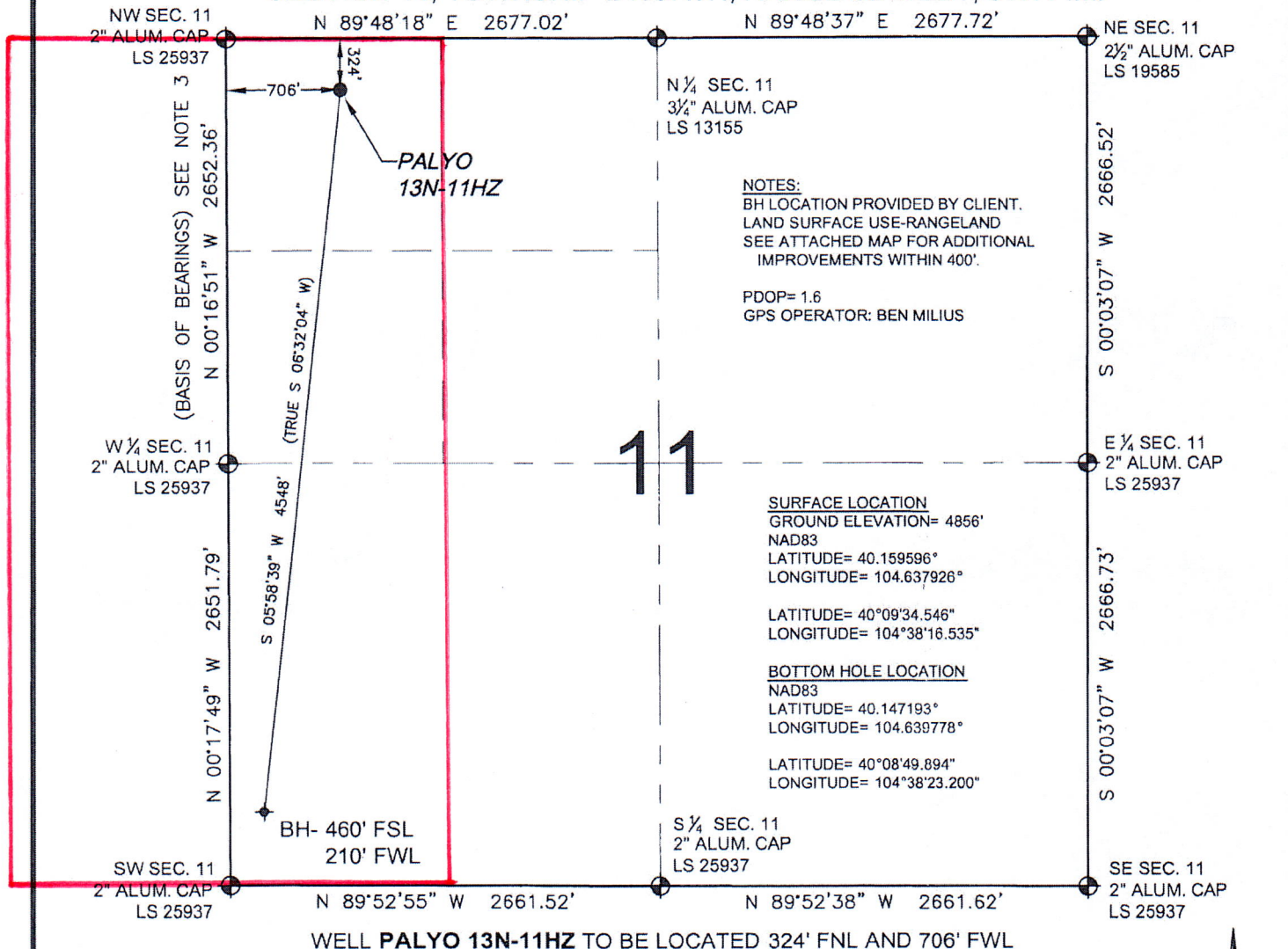

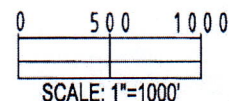
WELL LOCATION CERTIFICATE: PALYO 13N-11HZ
