**15. Comments:**

Railroad is 7629 +/- feet from site. There are no visible improvements within 400 feet of site. Nearest water well is 1820 +/- feet from site (Receipt; 0099768, Permit; 7909-D, use irrigation). There is a dry intermittent stream 1199 feet from site. The location is in a sensitive area due to being within the Northern High Plains Designated Basin. No COA's are needed for this site. It may be necessary to place a pumping unit on the facility at some point in the future. The pumping unit will require either one gas or one electric motor. There is a shut-in gas well 413 ft from the site (the Franson 943-28-42). The Franson 943-28-42 well is in the process of being plugged and abandoned. A Form 6 has been submitted and approved (document number - 400203945). Black Raven Energy is requesting that this Form 2A be approved subject to the P&A for the Franson 943-28-12 so that we can drill this new well immediately after the P&A work.
