Re: Beren update to COGCC staff regarding abatement and corrective action taken on certain leases located in Washington County

Dear Diana and John:

The purpose of this letter is to provide the Colorado Oil and Gas Conservation Commission ("COGCC") staff with an update on abatement and corrective action which Beren Corporation ("Beren") is doing on certain leases located in Washington County. As previously mentioned in its February 28, 2012, letter regarding these leases, Beren takes these matters seriously and will take the necessary steps to successfully abate or correct any legally cited rule violations. Accordingly, please consider the items listed below:

1. Lease and well signs were ordered on February 29, 2012, and should be shipped to Beren's field representative this week for wells and tank batteries. Signage will include road designations.
2. Placards have been placed on all tanks in the field.
3. Work has been completed on the Louder, Scott and Wright leases to raise skim pit nets to allow for additional freeboard. These corrective steps will ensure the netting is well above the liquid level of the pits. Similar work is scheduled for the Cook lease on March 13-14.
4. Beren has performed cleanup work (primarily pits and tanks) at the Cook, Scott and Wright leases. Refer to attached Exhibit A, which is a compilation of recent invoices describing work done.
5. Oily dirt excavated at the Cook, Loudder, Scott and Wright leases is/was stockpiled on location on plastic sheeting. This material is scheduled to be hauled to an approved waste disposal facility beginning March 13-14. It should be noted that Beren went through an



involved process to establish service with Waste Management at the Buffalo Ridge Landfill in Keenesburg. Beren was required to obtain an account as a "waste generator". See Exhibit B, non-hazardous waste manifest for Waste Management. In December 2011, oily dirt hauled from the Cook lease was done under the manifest of the dirt hauler.

6. Beren has contracted with a COGCC-recommended environmental consultant, John Mahoney, to conduct an environmental report on remediating the spill at the Cook tank battery (Spill Report #2221914). Beren plans to steam clean and pressure wash the treater shed and tanks, complete soil sampling in the area of the spill, and rebuild suitable berms at the battery.

Beren looks forward to continuing its working relationship with the COGCC staff as it takes steps to correct and abate certain conditions cited by staff at its operations in Washington County, and will continue to provide updates to staff as the situation warrants with the expectation that staff's concerns will be resolved in a mutually agreeable manner.




