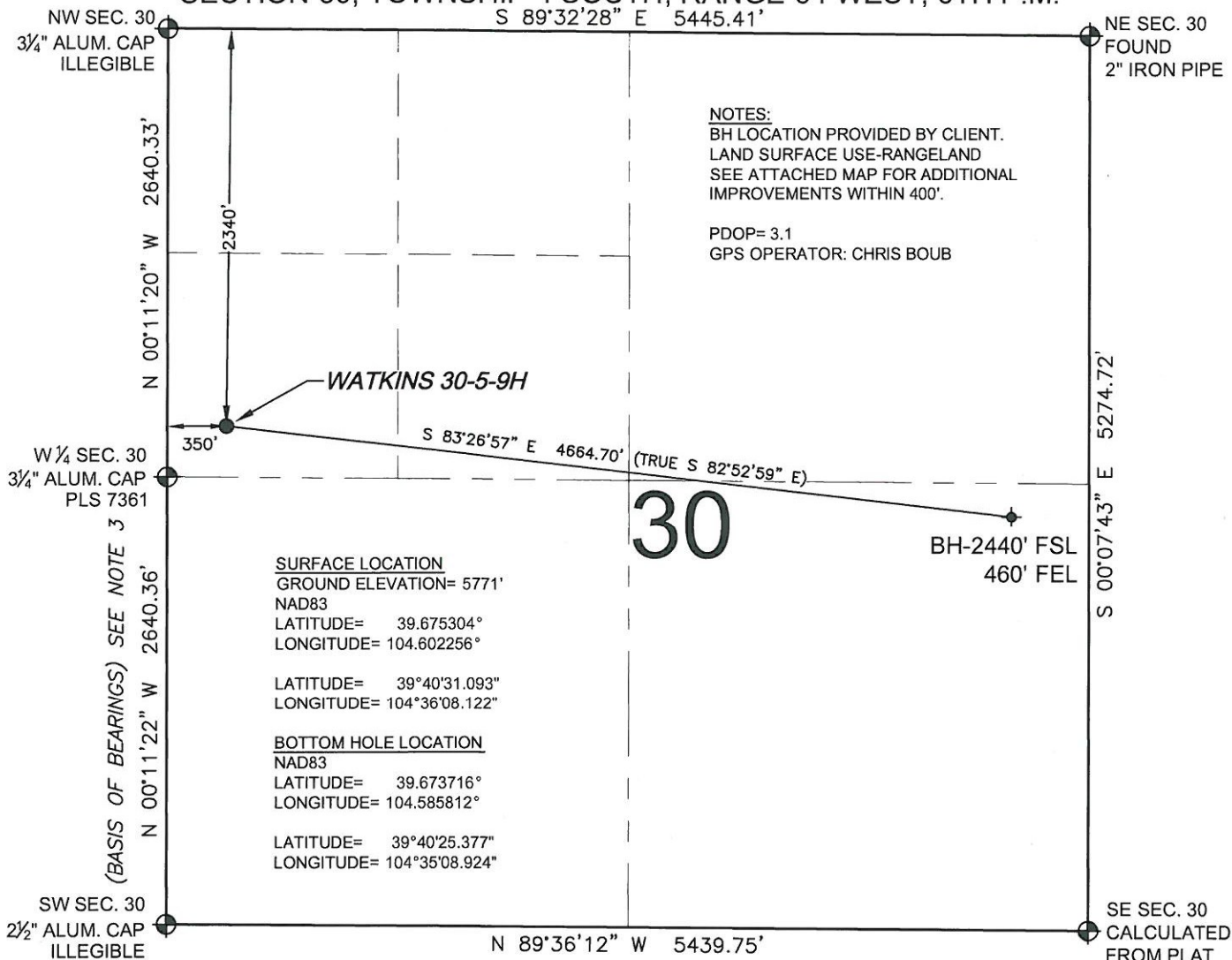


WELL LOCATION CERTIFICATE: WATKINS 30-5-9H
