15. Comments:

Distance to nearest railroad is greater than one mile. Nearest surface water 270' SW is a low area. Nearest water well 1219' SE is a domestic well; Receipt #9064342, Permit #43571 with a depth of 330' and a static water level of 92'. The reference area is on undisturbed ground immediately adjacent to and North of the pad location as shown in the location photo facing North. Location is a four-well pad consisting of the proposed Sarchet H23-20D, UPRC H23-21D, UPRC H23-25D, and UPRC H23-32D, multi-well plan attached. The production facilities for the proposed pad will be located within the pad disturbance along the access road to the South of the well locations and dedicated to the pad being permitted. There are no existing wells or production equipment currently at this location. A Wildlife Assessment report is included in this permit package; the well location is in a sensitive wildlife area. There is a gas sales line 150' off the County Road that we will be crossing on our access road that will be plated over to cross the pipeline. Due to the proximity to Milton Reservoir, the production facility will be lined and have a steel berm. Surface Use Agreement is attached to the Form 2 for the referenced wells.

If spills occur prompt cleanup is required to minimize any commingling of waste materials with stormwater runoff. Routine maintenance will be limited to fueling and lubrication of equipment. Drip pans will be used during routine fueling and maintenance to contain spills or leaks. Any waste product from maintenance will be containerized and transported offsite for disposal or recycling. There will be no major equipment overhauls conducted onsite. Equipment will be transported offsite for major overhauls. Cleanup of trash and discarded materials will be conducted at the end of each work day. Cleanup will consist of patrolling the roadway, access areas, and other work areas to pickup trash, scrap debris, other discarded materials, and any contaminated soil.
