



Lat40°, Inc. has determined the surface location of the REHDER X06-20D to be 1072' from the SOUTH line and 849' from the WEST line and the bottom hole to be 2500' from the SOUTH line and 850' from the WEST line as measured at right angles from the section lines of Section 6, Township 2 North, Range 65 West of the Sixth Principal Meridian, County of Weld, State of Colorado.




LEGEND
